ElectraNet awards SCADA Support and Project Services Contracts to PSC Australia

ElectraNet Pty Ltd (ElectraNet) is the principal electricity Transmission Network Service Provider (TNSP) in South Australia, operating as part of the National Electricity Market. ElectraNet's role is to own and manage the high-voltage transmission lines and substations that connect this State's electricity generation system to multiple customer connection points. They operate an EMS/SCADA system for control of their network which is one of the most extensive regional transmission systems in Australia, extending across 200,000 square kilometres.

PSC has a very successful history of providing SCADA/EMS (Energy Management System) services to clients across the world and has been providing SCADA support and project services to ElectraNet since 2007. In the 2013/14 fiscal year (July – June), PSC's management of the ElectraNet EMS/SCADA system achieved a record 0 Market

Minutes Lost (MML), a performance metric set and tracked by the Australian Energy Market Operator (AEMO).

PSC Australia recently tendered for and was awarded two four year contracts to provide SCADA operating support and project support services to ElectraNet. The services that PSC will provide under this contract will include SCADA development and commissioning, database and display maintenance, systems administration, 24x7 on-call response and support for specific applications.

PSC has a team of SCADA engineers based in Adelaide providing these services and can also call on PSC specialist engineers within Australia or around the world when required. The award of this contract is a major achievement for PSC Australia and we look forward to building on the strong relationship PSC has with ElectraNet and providing service excellence.

In addition to SCADA support and Project Services, PSC also provides transmission line engineering, telecommunications/networking design/build services and power systems engineering studies to ElectraNet.
